I am directed to inform you that the State of Kerala has taken several unique measures in response to the COVID 19 pandemic. Contact tracking and tracing is a crucial part of this response. The Covid 19 Jagratha portal now has a OR-code based 'Visitor Register Service' that can be utilized by both Government institutions and other establishments. It requires a one time registration at the end of which a unique QR Code is generated. The code can be stuck outside the office and anyone staff or visitors entering the premises has to scan the code, mark their presence and only then enter the establishment in question.

This system may be implemented for all staff of all institutions / offices under Health & Family Welfare Department and any visitors to the office. In the instance of a COVID positive being detected among the staff or visitors, it would be extremely convenient to contact all persons who were in the vicinity of the department on that date at a particular time. This can effectively replace the manual register that is cumbersome to maintain and

often unreliable.
