ORDER

As per Government Order read as Ist paper above, for the upgradation of Block Level Community Health Centres in the State to Block Level Family Health Centres and for introducing more treatment facilities and inpatient treatment, 76 Community Health Centres were selected as Block Level Family Health Centres and the necessary amount has been sanctioned for the provisions of essential facilities and equipments. Also vide Government Order read 2nd paper above, 76 more health institutions were upgraded to Block Level Family Health Centres. The Director of Health Services vide letter read as 3rd paper above, has informed that some errors occurred in the list of institutions in the Government order read as 2nd paper above and has furnished a revised proposal with regard to the development of 76 more institutions including the remaining Community Health Centres, selected Family Health centres and Primary Health centres in the revenue block where Community Health Centres do not exist, be converted into Block Level Family Health Centre.

Government after having examined the matter in detail are pleased to select the following 76 institutions to be developed as Block Level Family Health Centres.
