ORDER

As per the Government Order read as 3rd paper above, issued in compliance with the order of Hon'ble KAT read as 2nd paper, the Director of Health Services was directed to consider the option of Dr.Stanley George for inclusion in the Super Specialty Cadre as per his seniority and other eligibility criteria adopted for appointment in Government Order read as 1st paper and to submit a clear proposal to Government for an appropriate placing in the Super Specialty Cadre for taking a decision thereon.

2) In compliance with the direction of Government, as per letter read as 4th paper above, the Director of Health Services has informed that Dr.Stanley George, Consultant (Pediatrics) has been assigned the 1st position in the Provisional Seniority List of Super Specialty Cadre in Cardiology and the position of Dr Siar.M.A, who is holding the 1st position in the existing list, has been reassigned as 1A. Based on this revised seniority position, the Director of Health Services proposed the following steps to confer the consequential benefits as per the direction

of Government:

(i)To promote Dr.Stanley George as Chief Consultant Cardiology and to post him in District Hospital, Palakkad.

(ii)To revert Dr.Siar.M.A, who is working as Chief Consultant in District Hospital, Palakkad as Senior Consultant in Cardiology and to

post him in General Hospital, Thiruvananthapuram.

(iii)To revert Dr.Arun S.R. who is working as Senior Consultant in General Hospital, Thiruvananthapuram as Consultant in Cardiology and to post him in the newly created post of Consultant in Cardiology at Taluk Hospital, Punalur.

- 3) Government have examined the matter in detail and are pleased to issue the following orders:
- (i) Dr.Siar.M.A. who is working as Chief Consultant in Cardiology at District Hospital, Palakkad is reverted to the post of Senior Consultant in Cardiology and is posted at General Hospital, Thiruvananthapuram.
- (ii)Dr Arun.S.R. who is working as Senior Consultant at General Hospital Thiruvananthapuram is reverted to the post of Consultant in Cardiology and is posted in the newly created post of Consultant in Cardiology at Taluk Hospital, Punalur.
- iii)Dr. Stanley George, Consultant in Paediatrics, General Hospital, Ernakulam is appointed as Chief Consultant in Cardiology on temporary basis and is posted at District Hospital Palakkad.
