The candidates are directed to report for duty before the District Medical Officer of Health concerned within 15 days on publishing of the posting orders, failing which action will be taken to cancel the appointment. The candidates should produce the original certificates at the time joining duty that is to prove Educational Qualification, Date of Birth, Identity for verification.

Certificate of Physical Fitness obtained from a Medical Officer in Government service not below the rank of Civil Surgeon/Consultant.

Original Non Cremy layer Certificate of candidate being Sl.No. 4 ,Community Certificate of the candidate with Sl.No.5 and Advice Memo issued to all candidates from Kerala Public Service Commission should be verified (Copy attached)at the time of joining duty. The District Medical Officer of Health should verify the above documents before permitting the candidates to join duty.

The appointment of the candidates are subject to Rule 3(c) of the General Rules of the KS&SSR 1958.The appointment is purely provisional and the candidates is eligible for appointment in regular service only if the character and antecedents are found satisfactory on further verification. His/Her appointment shall be terminated without further notice, if the appointing authority is not satisfied with his/her conduct and antecedents on subsequent verification.

If there is any discrepancy found the candidates should not be allowed to join duty and the fact should be reported to this officer forthwith. After the candidate is allowed to join duty, the copy of identification certificates may be kept in the concerned file under safe custody.

The Entitlement Register shall be submitted to Accountant General, Thiruvananthapuram, by the candidate within one week from the date of joining date. The RTC (3 copies), Annexure I and Personal Memorandum should be forwarded to this office received from the candidates for PSC/Police Verification.The appointment shall be regularized only after the receipt of verification certificate from KPSC and Police authorities.
