S. R. O. No. 428/2018.—In exercise of the powers conferred by sub-section (1) of Section 2 of the Kerala Public Services Act, 1968 (19 of 1968), the Government of Kerala hereby make the following rules to amend the Kerala Public Health Subordinate Service Special Rules, 2017 issued under G. O. (P) No. 76/2017/H&FWD dated 12th December, 2017 and published as S. R. O. No. 805/2017 in the Kerala Gazette Extraordinary No. 2788 dated 21st December, 2017, namely:—

#### RULES

- 1. Short title and commencement.—(1) These rules may be called the Kerala Public Health Subordinate Service (Amendment) Special Rules, 2018.
  - (2) They shall come into force at once.
- 2. Amendment of the Rules.—In the Kerala Public Health Subordinate Service Special Rules, 2017 in the table under rule 4, against category 4,—
- (i) in column (1) after entry (A), for the entry "(A) Field Assistant/Insect Collector" the entry "(B) Field Assistant/Insect Collector" shall be substituted.
- (ii) in column (3), for the existing Note the following Note shall be substituted, namely:—

"Note:—Existing Field Workers having 5 years service and SSLC are exempted from passing Plus 2/VHSE or its equivalent and Diploma in Health Inspector Course. The Employees promoted as field assistant/insect collector based on the above provisions shall undergo multi purpose workers training immediately."

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

In the Kerala Public Health Subordinate Service Special Rules, 2017 issued as per notification under G. O. (P) No. 76/2017/H&FWD dated 12th December, 2017 and published as S. R. O. No. 805/2017 in the Kerala Gazette Extraordinary No. 2788 dated 21st December, 2017, the amendments proposed by the members of the Kerala Legislative Assembly was considered by the tenth session of the fourteenth Kerala

Legislative Assembly and the amendments proposed to delete the provision to have the qualification of Multi Purpose Workers Training/Health Inspector Course/Sanitary Inspector Course to get exemption from passing Plus 2/VHSE or its equivalent and Diploma in Health Inspector Course for the promotion to the post of Field Assistant/Insect Collector was accepted by the Assembly. Hence, the Government have decided to amend the said rules to that effect.

The notification is intended to achieve the above object.
