The Final seniority list of LD Clerks during the periods 1986-90, 1990-93, 1994-97, 1997-02, 2003-08 were published vide papers read as 1st to 5th above respectively.

The seniority list of UD Clerks, who were promoted during the period from 2000 to 2012, is being prepared at present. On verification of the service particulars of the promotes for the above purpose, it is noticed that the rank no of one more incumbent who obtained Inter District Transfer in the entry cadre was not lowered in the seniority list of LD Clerk and he was also seen promoted to the cadre of UD Clerk on the basis of this wrong seniority position.

As per the GOs read as 6th and 7th above, the seniority of an incumbent who obtained Inter District Transfer to other districts than from the recruited district will lose his / her seniority. An incumbent who is appointed as LD Clerk as per advice of PSC through District Recruitment Board shall entitle to get IDT without losing seniority, only after promotion to the cadre of UD Clerk. In all other cases of IDT, the incumbent shall lose the seniority and will be the junior most in the transferred district. They are eligible to reckon their seniority only with effect from the date of joining duty in the transferred district.

In this circumstance, it is provisionally decided to reassign the rank No of that incumbent, who obtained IDT to other districts than from the recruited district in the entry cadre, as detailed in <u>Annexure A</u> appended herewith. The promotion given to the above incumbent to the cadre of UD Clerks will also be re-examined after finalizing the proposal and the seniority in the cadre of UDC will be fixed accordingly.

If the incumbent aggrieved of the proposal shall file appeals within 15 days from the date of this notice.
