Smt Radhamoni.V.A. Junior Public Nurse has submitted a petition alleging that her seniority rank was lowered based on Inter District Transfer availed and she was denied promotion as PH Nurse. But the seniority of Smt. Sheeba who secured Inter District Transfer was not lowered and she was given promotion as PH Nurse.

Accordingly this case is examined in detail and found that her argument is genuine. On verification of service book of the incumbent, it was found that Smt.Sheeba.S was entered in Health Services as Junior Public Health Nurse Grade II on 30.12.1992 in Thiruvananthapuram district through PSC advice letter no.DTA(3)2539/88, DPSC TVPM dated 18.11.1992. But she secured Inter District Transfer two times in the entry cadre, first to Idukky district on 09.06.98 and then to Ernakulam district on 08.02.2001 respectively. As such she is only eligible to assign seniority as per her 2nd Inter District Transfer to Ernakulam on 08.02.2001 onwards. Hence the rank and seniority already assigned to Smt.Sheeba.S as serial no: 3012 in the seniority list of JPHN Grade II and as serial no:2881 in the seniority list of JPHN Grade I as on 30.01.94. without considering her inter district transfers have to be reassigned.

In this circumstances it has proposed to reassign rank no. 2134 A to her in between (2134) Smt. Jayalakshmi.P.T and (2135) Smt. Latha .K. as detailed below in the Seniority list of JPHN from 02.01.94 to 31.12.06.
