As per the order read 1<sup>st</sup> paper above revised preliminary gradation list of District Education and Media Officer/Health Education and Extension Officer/Social Science Instructor/Production and Distribution Assistant/Social Scientist for the period from 01/06/1994 to 31/12/2005 was published with provisions for appeals.
