## ORDER\_NO. ES 1 - 28695/2015/DHS/dtd.01/02/2016

In the order dated.18/03/2015 in OA No.1964/2014 by the Hon'ble KAT has directed the first respondent, Secretary, Health & Family Welfare department to consider and pass orders on Annexure A6 appeal, after hearing the applicant, Sri.Remasan.K.M within four months from the date of receipt of the order.

As ordered by the Hon'ble KAT, the applicant was heard by the first respondent, the Secretary. Health and Family Welfare Department. The main contention of the applicant is that, his rank No.446 in the seniority list referred 1<sup>st</sup> above may be refixed considering the fact that he joined in the cadre of Junior Health Inspector Gr.II on 22/11/2000, as those who joined in the said cadre after him are positioned above.

In this connection Government have directed to this office to examine the date of join of Rank No.47 to 54 in the cadre of Junior Health Inspector and refixe the seniority of Remeson.K.M in appropriate place in between them after hearing the affected parties.

On verification of relevant records of incumbent, it is found that Rank No.49 Sri.Ramesh Babu has joined in the cadre of Junior Health Inspector Gr.II on 16/10/2000 and rank No.50 Sri.Babu.P.N joined as Junior Health Inspector Gr.II on 01/12/2000. The applicant Ramesan.K.M joined in the cadre of Junior Health Inspector Gr.II on 22/11/2000. It shows that Rank No. 50 Sri.Babu.P.N whose date join is after that of the applicant.

Accordingly it was proposed to reassign seniority rank No. of Sri.Ramesan.K.M as Rank No.49 A in between Ramesh Babu, Rank No.49 and Sri.Babu.P.N, Rank No.50 as detailed below.A notice has been issued seeking appeal if any from the aggrieved vide read as

4th above. No appealshave been received in this regard. Hence the rank No proposed to Ramesan K.M in the notice is confirmed as detailed below
