In the Order dtd. 26/06/2014 of the Hon'ble Keral Administrative Tribunal, Thiruvananthapuram in OA No.674/2014 filed by Sri.Unnikrishnan Amior Fiealth Inspector Gr.II directed the 1st respondent Government to consider and pass orders on Annexure A2 in the OA in accordance with law after affording on opportunity of being heard to the applicant within 4 months from the date of receipt of a copy of the order.

In the Annexure A2 the main argument of the applicant was that in the case of PSC hands the seniority is to be considered as per Rule 27 (c) of Part II KS&NSR, i.e the date of advice. But in the case of By transfer appointment the seniority is to be considered on the date of arising vacancy after acquisition of prescribed qualification. So the seniority of the applicant is to be considered with effect from 12/10/2000 the date on which the vacancy arose for his appointment.

The applicant Sri.T.Unnikrishnan was entered in service as Last Grade servent on 21/06/1996 and he acquired technical qualification on May 2000. He was appointed by transfer as Junior Health Inspector Gr.II vide Order Mo.EG3-76498/04/DHS/dt.14/09/2004 and joined duty on 16/09/2004. In the combined seniority list of Junior Health Inspector for the period from 01/04/2000 to 31/10/2007 he was placed as Serial No.437.

As per Rule 28 (bb) Part – II KS&SSRs it is the date of occurrence of vacancy that is crucial for deterring promotion.

In this connection Government have directed to this office to revise the seniority positions of the applicant w.e.f 12/10/2000 and assign him his due seniority as per the condition laid in 3rd provision for Rule 27 (a) Part II KS&SSRs.

Accordingly it was proposed to reassign rank and seniority of Sri.T.Unnikrishnan as Rank No.389(A) in between Sri.Manoj.V.S and Sri.Vinod.P who were holding Rank No.389 and 390 respectively in the seniority list of Junior Health Inspector Gr.II for the period from 01/04/2000 to 31/10/2007. A notice has been issued seeking appeal if any from the aggrieved vide read as 4th above. Three appeals have been received in this regard. The appeals received were verified and necessary corrections have been made.

In these circumstances the rank No. proposed in the notice is confirmed as detailed below.
