In the Order dtd.26/06/2014 of the Hon'ble Kerala Administrative tribunal, Thiruvananthapuramk in OA No.675/2014 filed by Sri.Rajesh Puravankara Junior Health. Inspector Gr.II and others directed the first respondent, secretary Health & Family Welfare department to consider and pass orders on Annexure A2 to A4 in accordance with law after affording an opportunity to being heard to the applicants and other affected persons if any with in four months from the date of receipt of copy of the order.

The Government have heard the applicants Sri.Rajesh Puravankara, Sri.S.Biju.S.R, Sri.Sajeevan.P on 18/09/2014. The main argument of the applicant is that, in the case of PSC hands, the seniority is to be considered as per Rule 27 of (C) of Part II KS&SSR ie, the date of advice. But in the case of by transfer appointment, the seniority is to be considered on the date of arising vacancy after acquisition of prescribed qualification.

As per Rule 28 (bb) Part – II KS&SSR, it is the date of occurrence of vacancy that is crucial for determining the question for promotion. The departmental hands entitled to get seniority in the post only from the date of occurrence of vacancy on or after date on which be becomes qualified to the post as per special Rules.

In this connection Government have directed vide G.O cited second above to this office to revise the seniority positions of the applicants and assign due seniority from the date of occurrence of vacancy on or after the date on which they were qualified.

Accordingly it is proposed to reassign the rank and seniority position of the following incumbents after considering their date of entry in service completion of probation, date of acquision of qualification and occurrence of vacancy as detailed below.
