Smt. Rajani. O, Junior Public Health Nurse Grade II and Smt. Geethakumari. P, Junior Public Health Nurse Grade II has filed TA before the Honourable KAT for assignment of seniority ranks based on regularization of service and to delete the wrong ranks assigned.

The Honourable KAT in its order dated 30.09.13 in TA no. 5667/12 ordered to make changes in the seniority list of JPHN Grade II within three months from the date of receipt of the order.

On verification of the service book and other relevant records, it is found that the provisional service of the petitioners have got regularized with effect from 09.05.95 and 18.10.96 respectively in compliance of judgment of the Honourable Supreme Court and Government order as per reference 1<sup>st</sup> and 2<sup>nd</sup> above.
