The Preliminary seniority list of Senior Clerks who were promoted as Senior Clerk during the period from 17/06/2000 to 31/12/2012 was published as per order read 1st. The appeals received in this regard have been examined in detail as per merit with reference to the norms. Necessary corrections and modifications pointed out in the appeals deserving merit have been made in the order read 1st and the final seniority list of Senior Clerks who were promoted during the period from 17/06/2000 to 31/08/2012 is published herewith as detailed in the list appended.

On verification of the service details of the incumbents while preparing the seniority list, it was noted that certain incumbents have availed inter-district transfer in entry cadre/Leave without Allowance before declaration of probation. The seniority position of such incumbents in entry cadre are to be lowered based on the rules in force. But it is noted that the seniority of such incumbents has not been reviewed and therefore they have been promoted erroneously based on the previous incorrect seniority. Such cases found out has been reviewed in this order by issuing prior notice and the seniority position of concerned incumbents have been altered and placed in appropriate positions as per merit. The cases which require reversion consequent of review of seniority have also been omitted in this order.

The seniority of U.D.Typists/Senior Grade Typists/Selection Grade Typists/Stenographers who have changed their category to U.D.Clerk/Senior

Clerk has been assigned in accordance with the provisions laid down in orders read 2nd and 3rd.

The seniority is assigned in accordance with the date of occurrence of vacancy as mentioned in column no. 13& 14. Vaccancies arose up to 31/03/2012 have been taken into consideration. The factors such as declaration of probation in the cadre of LDC, date of acquisition of department test qualification and the rank No assigned in the cadre of LDC have also been taken in account for assignment of seniority. The incumbents who were promoted between 01/09/2012 and 31/12/2012 and those who were included in the preliminary list have been excluded in this final seniority list since they cannot be accommodated against the vacancies arose up to 31/03/2012.

The review of promotions if any with respect to the date of occurrence of vacancies shall be made by the concerned establishment sections of this office as per rules.
