## ORDER NO. ES3-76470/2014/DHS, DATED: 15/06/2015

As per letters referred 1<sup>st</sup> to 9<sup>th</sup>, the appeals well as service details in respect of 9 Nursing Staff regarding rectification of the anomalies occurred in the seniority list of, Staff Nurse Grade-II (1990-2002), Staff Nurse Grade-II (2003-2010) published vide orders referred 12<sup>th</sup> & 13<sup>th</sup> respectively have been forwarded. The points raised in the above said appeals and the service particulars have been examined in detail with all connected service details and found certain anomalies, such as non inclusion of name, non consideration of Inter District Transfer and Leave Without Allowances etc.

Accordingly vide paper read as 10<sup>th</sup> above, a notice has been issued from this office intimating the provisional decision to rectify the anomalies occurred in the seniority list. Smt.Assa Deep.T.S,Head Nurse, whose seniority position was proposed

to be re-assigned as per notice read 10<sup>th</sup> based on inter district transfer to Palakkad District, has submitted appeal read 11<sup>th</sup> stating that she was recruited through compassionate employment assistance scheme and she had opted Palakkad District for appointment but due to administrative reasons, she was initially posted to Wayanad District and later secured transfer to Palakkad, being her District of choice. She has submitted attested copy of her application under compassionate employment assistance scheme as proof in this regard and requested to retain her seniority position based on the statutory provisions in this regard. Accordingly, the matter has been examined and it is noted that the seniority position of Smt.Assa Deep.T.S can be retained as per rules and therefore the provisional decision made vide notice read 10<sup>th</sup> to re-assign her seniority position is hereby dropped. No other genuine appeals were received in this regard

In these circumstances, the provisional decision to rectify the anomalies occurred in the said seniority lists are finalized as detailed in the Annexure 'A' appended herewith.
