ORDER NO. ES3-48392/2017/DHS, DATED 21/11/2018

The Final Seniority List of Pharmacist Grade-II for the period from 1978-90 had been published vide this office order read as 1st paper above.

The above seniority list was challenged in the Hon'ble Kerala Administrative Tribunal and the Hon'ble Tribunal vide order dated, 25/7/2016 in OA 1271/2014 read as 2nd paper above has issued direction to the Government to reconsider the issue taking into consideration to the points raised by the petitioners. Accordingly, Government have issued sanction to revise the seniority list of Pharmacist Grade-II for the period from 1978-90 vide order read as 3rd paper above.

As such, on verification of the service records who entered in service during 1978-90, it was found that certain incumbents were given Rank Number without considering the Inter District Transfer/Leave Without Allowances secured by them. Accordingly the existing seniority list of Pharmacist Grade-II (1978-90) was revised by lowering the seniority position of the ineligible persons, who secured the Inter District Transfer/Leave Without Allowances, vide this office order read as 4th paper above. In continuation to the above, Government letter vide 9th paper above have directed to revise the seniority list of Pharmacist Store Keeper based on the revised seniority list of Pharmacist Gr.II (1978-90).

In this circumstances, it is provisionally decided to revise the existing final seniority list of Pharmacist Store Keeper for the period from 1/1/2008 to 31/12/2014 and the preliminary seniority list of Pharmacist Store Keeper as on 1/1/2017 which had already been published vide order read as 5^{th} , 6^{th} , 7^{th} & 8^{th} paper above.

All the above said lists are now combined and prepared by excluding the ineligible officers who were already lowered in the basic revised seniority list of Pharmacist GrII for the period from 1978-90. Accordingly, the preliminary seniority list of Pharmacist Store Keeper for the period from 1/1/2008 to 31/12/2016 was published vide order read 10th above, inviting appeals from aggrieved parties regarding any anomalies and there is no eligible appeals found in this regard.

In this circumstances, the revised preliminary seniority list of Pharmacist Store Keeper for the period from 1/1/2008 to 31/12/2016 is confirmed and appended to this order.
