As per letters referred 1st to 8th, the appeals in respect of 8 Nursing Staff regarding rectification of the anomalies occurred in the seniority list of, Staff Nurse Grade-II (1990-2002), Staff Nurse Grade-II (2003-2010) published vide orders referred 10th & 11th respectively have been forwarded.
