As per letters referred 1<sup>st</sup> to 5<sup>th</sup>, the appeals submitted by 6 Nursing Staff to rectify the anomalies occurred in the seniority list of, Staff Nurse Grade-II (1990-2002), Nurse Grade-II (2003-2010) published vide orders referred 7<sup>nd</sup> & 8<sup>th</sup> respectively have been forwarded. As per this office order referred 6<sup>th</sup>, one staff nurse included in Seniority list referred 8<sup>th</sup> have been granted Inter District transfer. The points raised in the above said appeals have been examined in detail with all connected service details and found certain anomalies, such as non inclusion of name, non consideration of Inter District Transfer and Leave Without Allowances etc. Also the seniority of the incumbent who availed Inter District Transfer vide order referred 6<sup>th</sup> is subject to review.

Accordingly vide paper read as 9<sup>th</sup> above, a notice has been issued from this office intimating the provisional decision to rectify the anomalies occurred in the seniority list. No genuine appeals are seen received in this regard.

In this circumstances, the provisional decision to rectify the anomalies occurred in the said seniority lists as detailed in the Annexure 'A' appended herewith is finalized. It was also noted that the correction of seniority position of incumbent noted as Sl. No. 1 in the notice read 9<sup>th</sup> above (Smt.Alphonsa.K.A) have already been made. Hence her name is excluded in this order.
