As per the reference 1st cited, 22 Pharmacists have submitted representations to rectify the anomalies occurred in the Final seniority list of Pharmacist Grade-II 1978-1990, 15/12/1990 to 31/12/1998 and 1/1/1999 to 31/12/2008 published vide references 2nd to 5th cited above respectively. The points raised in their request have been examined in detail with all connected service details and found certain anomalies, such as non inclusion of name, correction of date of birth, correction in Rank No. etc.

Accordingly vide paper read as 5th above, a notice has been issued from this office intimating the provisional decision to rectify the anomalies occurred in the seniority lists. No genuine appeals are seen received in this regard.

In this circumstances, the provisional decision to rectify the anomalies occurred in the said seniority lists is finalized herewith as detailed in the Annexure 'A' appended. The review of seniority list of Pharmacists for the period from 01/01/1978 to 14/12/1990 has been challenged in the Hon. Kerala Administrative Tribunal vide OA No.1271/14 filed by Smt. Jaimol & others. The finalization of the said seniority list is subject to the final order of the Hon. Tribunal in the above case. Therefore the inclusion of two of the

incumbents in the seniority list of 78-90 (Smt.Geetha.K.V & Smt. Ganga Bhai.S) proposed vide notice read 5th has been kept in abeyance and their name has been excluded in this rectification order. Their case will be taken up as per merit consequent on further proceedings based on the final order of the Hon. Tribunal in above case
