As per order referred above, one post each of Senior Consultant (Cardiology) and Consultant (Cardiology) has been created in General Hospital, Thiruvananthapuram in connection with setting up of Cath Lab. Creation of posts under the speciality of Cardiology has been done for the first time in this Department. Since the process is a new venture and no seniority list exists at present in the speciality of Cardiology, it has become necessary to prepare a seniority list of Specialist doctors under the speciality of Cardiology in order to effect posting in the newly created posts. Attested copies of concerned certificates should be attached along with the proforma. In the case of Medical officers who had undergone DM Cardiology under Service Quota, they are bound to render their service as Cardiologist as per the requirement of the Department. Hence submission of the above mentioned service details in their

case is compulsory. Any laxity in such cases will be viewed seriously and the concerned officers will be subject to disciplinary action as per rules.

The District Medical Officers are directed to circulate this information to all the Medical Officers under their control and also to collect the service details in prescribed proforma from the qualified incumbents. The proforma along with supporting documents should be submitted to the District Medical Officers either directly or through proper channel on or before \$\frac{12}{108}/2015\$. The District Medical Officers shall verify the proformas and submit the same to ES Section this office by special messenger on or before \$\frac{12}{108}/2015\$.

Since posting of Medical officers in the newly created posts has to be done immediately, all the concerned officers are directed for urgent necessary action in this regard.
