- 5. He/she shall report for duty before the concerned District Medical Officers with all relevant records in original to prove their Qualification, Date of Birth, Certificate of Registration with Travancore-Cochin Medical Council, Medical Certificate of Physical Fitness of good health obtained from a Medical Officer not below the rank of Civil Surgeon in Government Service (as per G.O(P) No. 20/2011/P&ARD dated 30/06/2011). - 6. The application for correction of date of birth, if any required should be made by the candidates within five years from the date of entry in service.
