The candidates should produce the following documents at the time of joining duty.

- 1. Original documents to prove the date of birth and Educational Qualification.
- 2. Certificate of Physical fitness obtained from Medical Officer in Government: Service not below the rank of Civil Surgeon/Consultant.
- 3. The Original One Time Verification Certificate
- 4. The Selection to the post of Nursing Tutor is subject to the final disposal of Hon'ble High Court in INA No 403/12.

The candidate is placed on probation for a total period of 2 years duty within a continues period of 3 years.

The candidate should pass the Account Test for Executive Officers (Kerala) or Accountant Test (lower) for declaration of probation.

The appointment of the candidate is subject to Rule 3 (C) of the General Rules of Kerala State Subordinate Service Rules 1958 and the service is liable to be terminated without prior notice. The appointment is purely provisional and the candidate is eligible for appointment in regular service only if the character and antecedents found satisfactory on verification.

The Head of institution should satisfy himself about the identity of the candidate before allowed to join duty. For this purpose, the scanned copy of identification certificate produced by the candidate at the time of selection test is enclosed herewith. There is a signature of the candidate on the Passport Size Photograph affixed to the identification certificate. The Candidate has also signed the declaration given below the Photograph affixed on the identification certificate. The Photograph and the signature of the candidate should be verified and the fact may be recorded by the Head of the office on the scanned copy of the identification certificate itself. If there is any discrepancy the candidate should not be allowed to join duty.

The Entitlement register shall be submitted to Accountant General, Thiruvananthapuram by the candidate within one week from the date joining duty. The copy of certificate to prove Qualification and Identification of the candidate should be forwarded to this office for Public Service Commission for verification. The appointment shall be regularized only after obtaining a verification certificate from Kerala Public Service Commission, and Police verification Certificate.

The head of institution will obtain the enclosed annexure I duly filled up and signed by the candidate before they are allowed to join duty and forward the same to this office for further action. The head of institution should verify the documents mentioned above to see that the particulars given by the candidate shown in the statement is correct before they are admitted to join duty and also satisfy himself about the identification of the candidate with reference to photograph and signature affixed in the identification certificate which is enclosed.

The date on which the candidates join duty should be reported. Application for correction of Date of Birth if any should be made by the candidate within 5 years from the date of entry in service laid down in G.O.(Rt.)No. 45/91/P&ARD, dated 31.12.1991.

In the event of discharge from service for want of vacancies the candidates may either register their name in the office of the Public Service Commission from where they were advised and get themselves re appointed to the post in the Department in case they desire to continue probationers in the post from which they were discharged vide Government Circular Memorandum No 3737/Rule-1/90/P&ARD, dated 29.03.1990 and Government Order No.7/1991/P&ARD, dated 15.02.1991.

They have not eligible for joining time and leave they are instructed to report before the Head of the institution for duty on the next day on reporting duty before the undersigned.
