Certificates of physical fitness obtained from Medical Officer in Government Service not below the rank of Civil Surgeon/Consultant.

Original Non-Cremylayer certificate of candidates being sl. No. 1,4 & 9 and Community Certificate of the candidate with sl. No. 2 should be verified at the time of their joining duty.

The District Medical Officer of Health should verify the above documents before permitting the candidates to join duty.

The appointment of the candidates are subjects to Rule 3 © of the General Rules of the KS&SSR 1958. The appointment is purely provisional & the candidates is eligible for appointment in regular service only if the character & antecedents are found satisfactory on further verification.
