It is noted that the General Conditions regarding appointment to the post of Assistant Surgeon has not been included in their posting orders. Accordingly, the following conditions are hereby included in the orders read above.

- (1) Their appointment to the post of Assistant Surgeon will be in the scale of pay of Rs.45800-89000 and under Rule 9(a)(i) of Kerala State and Subordinate Service Rules 1958.
- (2) Their appointment will be subject to the condition that the same shall be terminated without further notice if the appointing Authority is not satisfied with his conduct and antecedents on subsequent verification.
- (3) They shall be eligible for appointment in regular service in accordance with rules only if their character and antecedents are found satisfactory on subsequent verification. The appointment will also be subject to Rule 3(C) of General Rules and Subordinate Service Rules 1958.
- (4) They are bound to work in rural areas as and when posted.
- (5) They shall report for duty before the concerned District Medical Officers with all relevant records in original to prove their Qualification, Date of Birth, Certificate of Registration with Travancore-Cochin Medical Council, Medical Certificate of Physical Fitness of good health obtained from a Medical Officer not below the rank of Civil Surgeon in Government Service (as per G.O(P) No. 20/2011/P&ARD dated 30/06/2011). Those who are in reservation quota shall produce the original Community Certificate and Non-Creamy Layer Certificate.

- (6) The application for correction of date of birth, if any required should be made by the candidates within five years from the date of entry in service.
- (7) In the case of candidates who fail to join duty within the stipulated time, their appointment will be cancelled and the vacancy will be reported to PSC as Not Joining Duty.

The orders read 2<sup>nd</sup>. stand modified to the above extend.
