SANCTIONING OFFICERS WITH SPECIFICATION OF THEIR SCALES OF PAY-  
ORDERS ISSUED.**

### ORDER

The upper Monetary Limit for sanctioning Temporary Advance/Non-refundable Advance by various categories of Sanctioning Authorities have been revised as per Government Order read as 1<sup>st</sup> paper above and the scales of pay to each category of officers were specified as per Government Order read as 2<sup>nd</sup> paper above.

Now, it has been brought to the notice of the Government that the Upper Monetary Limit specified therein is causing undue delay and inconvenience in sanctioning advances consequent on revision of pay and allowances of State Government Employees. It has also been noticed that the scales of Pay specified to different categories of Sanctioning Authorities have been revised consequent on Pay Revision.

Government have examined the matter in details and are pleased to revise the existing Upper Monetary Limit to various categories of sanctioning Authorities, in partial modification of the Government Order read as 1<sup>st</sup> paper above. The Upper Monetary Limit fixed for different categories of Sanctioning Authorities shall be subject to General Provident Fund rules and delegation of powers granted to the Officers.
