## ORDER

The Kerala Administrative Tribunal in its interim order read as 5th paper above has directed the second respondent, the Government to take a decision on Annexure A4 representation submitted by Dr.Lisha read as 1st paper above within a period of three weeks from the date of receipt of a copy of the order.

- 2) The applicant Dr.Lisha.R, Consultant (Dental) has been working at District Hospital, Mananthawady since December 2016. She had sought a transfer to General Hospital, Manjeri in anticipation of a vacancy. But as per Government Order read as 2nd paper above, Dr.Sheeba, Junior Consultant (Dental) at General Hospital, Neyyattinkara was promoted to the post of Consultant (Dental) and posted at General Hospital, Manjeri. Aggrieved by this the applicant filed OA (EKM) No.1280/2019 before the Hon'ble Tribunal.
- 3) As per Government Order read as 3rd paper above, the third respondent, Dr.Sheeba who has been transferred to General Hospital. Manjeri was given working arrangement to General Hospital, Neyyattinkara for a period of six months.
- 4) In the interim order read as 4th paper above, the Hon'ble Tribunal directed the second respondent, Government to take a decision on Annexure A4 representation submitted by

Dr.Lisha within a period of three weeks from the date of receipt of a copy of the order, especially as the third respondent has been retained in Neyyattinkara itself.

- 5) The Annexure A4 representation dated 05.01.2019 was submitted by Dr.Lisha, Consultant (Dental). Since she has been working at District, Mananthawady, a difficult rural centre for more than a period of two years, she requests to post her at General Hospital, Manjeri, Malappuram, Malappuram being her native district.
- 6)The Director of Health Services as per letter read as 6th paper above reported that Dr.Lisha submitted her application for transfer to General Hospital, Manjeri only after Dr.Sheeba's posting at that station. Since Dr.Sheeba.R is posted at Genral Hospital, Neyyattinkara on working arrangement basis, her hen hes in General Hospital, Manjeri, and there is no vacancy to the post of Consultant (Dental) at General Hospital, Manjeri. There is one post of Consultant (Dental) and three posts of Junior Consultant (Dental) in General Hospital, Manjeri, but only one post of Consultant (Dental) and one post of Junior Consultant (Dental) are there in District Hospital, Mananthawady. The Director of Health Services reported that the request of Dr.R.Lisha to post her at General Hospital, Manjeri cannot be done due to non availability of vacancy and she should be retained at District Hospital, Mananthawady.
- 7) Government examined the matter and decided to reject the request of Dr.Lisha.R, Consultant (Dental) (Annexure A4) to grant her posting at General Hospital, Manjeri and the interim order dated 17.01.2020 in OA (EKM) No.1280/2019 filed by Dr.Lisha.R is thus complied with.
