As per the order read 5th above 11 Senior Superintendent/ Lay Secretary and Treasurer were sanctioned percentage based Higher Grade as per special rules that is 25% of the total strength. Later it was found that 8 more Senior Superintendent/ Lay Secretary and Treasurer are also eligible to get percentage based Higher Grade due to seven retirements and one is the expire of a Senior Superintendent Sri. Sunilkumar. V.K.

In the Pay Revision Order read above, percentage based Higher Grade was sanctioned to Senior Superintendent/ Lay Secretary and Treasurer and Interchangeable posts as per special rules that is 25% of the total strength. Accordingly the strength of upgraded posts has been fixed as 36 Numbers. There are 17 employees now working in the eadre of Senior Superintendent/ Lay Secretary and Treasurer and Interchangeable posts as per special rules enjoying the percentage based higher grade. As such 19 officers in the above Cadre has to be eligible for the percentage based higher grade in the scale of pay of Rs. 40,500 85,000/(Revised). But as per the order read as 5th above only 11 persons are included in the order instead of eligible 19 incumbents. Here the above order is modified and included 8 incumbents whose names excluded in the above said order and the order is made good accordingly.
