- 1. The DRB candidates who are appointed through PSC will have their seniority with effect from the date of PSC advice.
- 2. The DRB candidates who are appointed through more than one PSC will have their seniority with effect from the date of Advice of last PSC recruitment.
- 3. If more than one person was appointed in the same advice date, the seniority position will be calculated on the basis of their serial number in the appointment order/ advice letter.
- 4 The staff Nurses Gr II, who were appointed through Dying in harness scheme, will have their seniority on the basis of their date of appointment order.
- 5 The Staff Nurse Gr II who availed joining time more than 90 days from the date of order of appointment will have their seniority assigned with effect from the date of their joining.
- 6 The DRB candidates will loss entire seniority while securing Inter District Transfer to district other than their district of appointment.
- 7 The Staff Nurses Gr II who availed LWA (under Appendix 12 A,12 B &12 C) before declaration of probation, will have their seniority assigned with effect from the date of rejoining duty after LWA.

A Preliminary seniority list of Staff Nurse Gr II for the period from 01/01/2003 to 30/06/2010 has been prepared and circulated to all through the concerned District Medical Officer of Health and also circulated through the official website of DHS vide this office order read as 2<sup>nd</sup> above. All the appeals received from the staff Nurses in this regard has been considered on merit taking in to account the rules regulations stipulated in KSR & KSSR and are given appropriate places in the final list.
