ORDER

As per the order read as 3rd paper above, deputation appointment of Dr.Ambika.V, Assistant Surgeon, Vilakudy Primary Health Center to Government Medical College, Kollam in the post of Senior Resident in Pulmonary Medicine Department was extended for an another one year w.e.f 20.12.2019.

2. As per the letter read as 5th paper above, the Director of Medical Education has informed that the deputation granted to Dr. Ambika. V will be completed on 19.12.2020 AN and also informed that she had requested to extend her deputation in the present post of Senior Resident or as Junior Resident in Pulmonary Medicine Department at Government Medical College, Kollam. Since the senior resident posts in Government Medical College, Kollam all are being filled by appointing P.G bonded candidates as part of their bonded obligation, Director of Medical Education has recommended to extend the deputation appointment of Dr. Ambika. V in vacant post of Junior Resident by considering the emerging need of doctors at Government Medical College, Kollam for facing the Covid situtation. The Principal has also recommended to extend her deputation in the post of Junior Resident (Pulmonary Medicine). No objection certificate read as 4th paper above from the Director of Health Services for

extending the deputation of Dr. Ambika. V has also enclosed in the proposal.

- 3. Government have examined the matter in detail and are pleased to accord sanction for the deputation of Dr.Ambika.V, Assistant Surgeon, Vilakudy Primary Health Center to Government Medical College, Kollam in the post of Junior Resident in Pulmonary Medicine Department for a period of one year w.e.f 20.12.2020, on expiry of her present deputation in the post of Senior Resident. Her deputation period in the post of Junior Resident will be considered along with her deputation in the post of Senior Resident for counting the continuous period of five years in the aggregate allowable as per the rules.
- 4. During deputation period she will be eligible to the salary of her parent Department. In the event of overstaying on deputation without Government permission, she will be liable to disciplinary action as per Kerala Service Rules, Part 1, rule 140(C) and the period of overstay will not be counted for the purpose of pension and that any increment due during the period of overstay will be deferred with cumulative effect, till the date on which she rejoins her parent cadre. No ex post facto approval for regularization of overstay on foreign service will be allowed. She will be precluded from drawing pay and allowances from the date on which the sanctioned term of deputation expires. She will be relieved of her duties and reverted back to her parent Department on the date of expiry of the sanctioned period of deputation unless Government have extended her period of deputation, prior to the date of its expiry.
