Government have ordered that 1/3rd of the total post of District Malaria Officer will be on Higher Grade in the Scale of Pay of Rs.21240-37140 (Pre-revised).

Accordingly 5 senior most candidates from the seniority list read 2nd above was granted 1/3rd Higher Grade promotion in the scale of pay of Rs.21240-37140 vide the orders read 3rd and 4th above. Among these District Malaria Officer (HG), Sri..Unnikrishnan.R retired from service on 31/3/2017 and Sri.Sasi.M.S was promoted as Assistant Director (Entomology) vide the order read 5th above and he joined duty in the said cadre on 1/08/2019 FN. The next Senior most candidates in the seniority list read 2nd above are the candidates serially numbered 7 and 8 named Biju Babajan and Ashok Kumar.V.C respectively. But Biju Babajan expired on 15/8/2010. Hence Sri.Ashok Kumar.V.C Sl.No.8 and Sri.Suresh.T. Sl.No.9 are the next Senior most candidates in the seniority list read 2nd above eligible for the 1/3rd Higher Grade promotion as on the vacancy on 1/04/2017 and 1/08/2019 respectively.

Therefore order is hereby issued granting 1/3rd Higher Grade promotion to Sri.Ashok Kumar.V.C, District Malaria Officer (Rtd.) and Sri.Suresh.T, District Medical Office (Rtd.) details of whom are mentioned below, in the scale of pay of Rs.40500-85000 with effect from the date noted against their name.
