The Principal of the School of Nursing / Junior Public Health Nurse Training Centre should verify the original certificates produced by the incumbents at the time of their joining duty & satisfy themselves that the appointees possess any one the following qualifications.

- a. Msc/Bsc Nursing Degree in Nursing (Basic or post basic) from a recognized university and recognized by the Indian Nursing Council.

- b. Diploma in Nursing education & Administration from a recognized university and recognized by the Indian Nursing Council.
- c. Registration with Kerala Nurses & Midwives Council as Nurses & Midwives

No extension of joining time will be allowed to the incumbents.

The date of relieve & the report of transfer of charges should be forwarded to this office promptly through the DMO(H) concerned.

The incumbents are placed on probation for a total period of one year duty within a continuous period of two years.

All the incumbents should pass the Account Test for Executive Officers (Kerala) or Account Test (Lower) for declaration of probation.

If any incumbents who are on LWA or unauthorized absence or under suspension need not be relieve & the fact should be reported to the undersigned without fail.
