The incumbents are placed on probation for a period of one year on duty within a continuous period of two years from the date of joining the promotion post.

The District Medical Officers of Health concerned will issue posting orders to the incumbents immediately and requested to verify the whereabouts of the promoted incumbents with reference to their service book before effecting posting.

The Head of Institution shall relieve the incumbents under their control on receipt of posting orders from the District Medical Officer of Health concerned without waiting for substitute.

The Head of Institution shall not relieve the incumbents, if there is any disciplinary action pending against them and it should be reported to this office forthwith.

If any of them has been transferred from the stations noted in the order, the Head of Institution concerned shall redirect the order to the new station where the incumbent is now working.

Those who have already enjoyed grade promotion shall not be allowed for relinquishment of promotion.

If any of the qualified hands are not included in this list, their claim may be considered on submitting the relevant documents to substantiate their claims within 10 days from the date of this order.
