### GUIDELINES FOR PARTICIPANTS

#### "AGENTS OF CHANGE": by Field Foot Soldiers

- Includes JPHN/PHN/PHNS/JHI/HI/HS/ Field Staff of any national Health program in Kerala
- Any success story from the field in which the foot soldier was a change agent may be presented. Examples – How you improved the immunisation coverage in your area, How you addressed a health problem which occurred during lockdown..
- Oral presentation in Malayalam PPT is not mandatory 15 minutes per talk 10 min talk, 5 min discussion
- Send the content in Malayalam as a 1-Page pdf document to q4ekerala@gmail.com

"BRAINWAVES CHALLENGE": Inviting simple, locally adaptive and & feasible solutions for a positive change in health - for Field officers/ Students and Faculty

- TEAMS can submit solution proposals (2-5 persons per team, maximum 5)
- Medical/Dental/Nursing/Paramedical, Undergraduate/Post graduate
   Students/Faculty from Govt/Private Medical Colleges in Kerala can present
- From Health Services sector, Medical Officers/Program managers may team up and submit project proposals
- Interdisciplinary team work is encouraged
- THE PROJECT/SOLUTION should be context-specific and carefully catered to the existing health landscape of a given geographic area/ health care setting. Solutions should take into consideration the strategic set of actors to move the issue. The proposed solutions should be financially sustainable with the potential for real-world adoption, scale-up, and strong likelihood of achieving a lasting impact. The idea for proposal should be new and have policy relevance. It should not be an on-going project.
- Priority Areas for the State (but not limited to):
  - COVID -19 Vaccine related aspects Addressing Vaccine Hesitancy,
     Achieving swift and efficient Roll out of vaccine in Kerala
  - o IEC in COVID -19 Control Impact Assessment and Newer Solutions
  - Clinical and Field management of COVID
  - o Non COVID management in the field and hospitals
  - Dealing with Emerging and Re-emerging diseases in the Kerala Context
  - Antimicrobial Resistance One Health Approach
  - Pandemic Preparedness for the future

- In case of research proposals by undergraduate/postgraduate students Two guides are needed - a Subject expert and a Research expert - preferably, but not necessarily from the same institution
- Word limit: Maximum 2000 words
- A neat and legible Microsoft word document should be prepared in the following format (in English):
  - o TITLE
  - BACK GROUND of the problem including Related SDG goal/target/indicator (Maximum 300 Words)
  - SOLUTION CONCEPT (may include schematic diagrams)
  - ACTION PLAN to execute the concept (In case of research study, the protocol) – How will you execute your idea in the hospital/field
  - o **OUTCOME/IMPACT** expected
  - MONITORING AND EVALUATION PLAN How will you monitor the implementation progress and evaluate the impact of your solution?
     What would be your key benchmarks, measures and targets?
  - RESOURCES required Including human resource, budget, materials and time (Gantt chart may be added). Is your project/solution sustainable? Any funding sources identified?
  - POLICY RELEVANCE Does your proposed solution bring a positive change in the health policy at a local/regional/state level? If so, how
  - SCOPE, LIMITATIONS AND CHALLENGES
