### **ORDER**

As per Government order read above, Government have accorded sanction for the implementation of Kerala Cancer Control Strategy and the constitution of Apex body and Executive Committee for cancer control strategy. Kerala Cancer Control Strategy recommends the formation of Kerala Cancer Registry. Government examined the proposal of Kerala Cancer Registry project submitted by three apex cancer centres and oncology wings of Government medical colleges. The state wide cancer registry is important for cancer control activities and interventions and to plan appropriate strategies for cancer care. This is expected to cover the entire state of Kerala providing authentic data on cancer incidence and mortality enabling the government to prioritise the targets in cancer care, develop and implement policies on cancer control, early detection strategies and plan economic flow in cancer care.

2. The Kerala Cancer Registry shall be under the Apex committee for supervising and formulating implementation strategy for Kerala Cancer Strategy and it will be monitored and implemented by a steering committee constituted for the purpose as follows.

- 3. Any reservation or query about notifying of cancers and functioning of cancer registries shall be dealt by the steering committee from time to time.

Government have examined the matter in detail and are pleased to approve the Kerala Cancer Registry Project and accord sanction to establish the Kerala Cancer Registry through a combined activity of three population based cancer registries in Regional Cancer Centre Thiruvananthapuram, Malabar Cancer Centre, Thalassery and Cochin Cancer and Research Centre, Ernakulam and the Hospital Based Cancer Registries in the Government medical colleges, District hospitals and other cancer care facilities/establishments both in private, cooperative and public sectors.
