The Head of Institutions concerned are directed to relieve the drivers in advance. The custodian of the vehicle should ensure that all the vehicles are in good condition and its statutories are updated and should hand over the vehicle as follows. If any of the vehicles statutories like insurance/fitness etc will expire within the tenure, the Hospital authorities will have to pay in advance, the expenditure incur to the Foreman Mechanic Pathanamthitta.

The Hospital authorities shall ensure the equipments installed in the Ambulance are working properly and if not, shall rectify all the defects before handing over to the Health Transport Workshop authorities concerned.

The Consecutive batches should report before the District Medical Officer of Health, Pathanamthitta on the FN of the allotted day itself and take delivery of the Vehicles from the concerned driver after observing the guidelines issued by the District Medical Officer of Health, Pathanamthitta. The sixth batch should handover the vehicle to the Chargeman or Foreman Mechanic of Health Transport Workshop attached to the district to which the vehicle is attached (As stated in the Ist Column).

If any of the above drivers who draw salary from HMC are on duty, the same remuneration will be continued by the HMC as there is no provision for salary in Sabarimala Pilgrimage Fund allotted by the Government to the District Medical Officer of Health, Pathanamthitta.

The drivers deputed are directed to hand over two stamp size photograph to the Nodal Officer (Sabarimala) for issuing Identity Card.

Change or modification of the above posting shall be done only in unavoidable circumstances. In such cases alternate arrangements will be made by the concerned District Medical Officer of Health under intimation to the undersigned. Any laxity in this regard will be viewed seriously.

Disciplinary action will be initiated against those drivers who fail to report for duty in time or fail to perform duties

TA/DA for the drivers will be paid by District Medical Officer of Health, Pathanamthitta as per rules, according to the availability of fund.
