The appointed shall be regularised only after obtaining a verification certificate from KPSC and police verification.

The Head of the institution see the particulars given by the condition shown in the statement is correct before he/she is admitted to join duty and also satisfy herself about the identification of the candidate with reference to the photograph and signature affixed in the identification certificate which is enclosed. After the candidate is allowed to join duty the identification certificate verified and found acceptable should be kept pasted in the Service Book of the candidates. The date on which the candidates join duty should be reported. Application for correction of Date of Birth if any should be made by the candidate within 5 years from the date of entry in service laid down in G.O(Rt)45/91/P&ARD Dated:31/12/1991.

If the candidates failed to join duty within the stipulated time the fact should be reported to this office of the candidate after the expiry of the joining time.

In the event of discharge from service for want of vacancy the candidates may either re regular their name to the office of the Public Service Commission from

where they were adviced and get through re appointed to the post the department in case they desire to continue as probationer in the post from which they were discharged vide Government circular memorandum No.3737/Rule.1/90/P&ARD Dated:29/3/90 and Government Order No.7/1991/P&ARD Dated:15/2/91.
