### ORDER

Dr.Pushpakumari.C.V, Consultant in Obstetrics and Gynaecology, Victoria Hospital, Kollam was transferred to W&C Hospital, Alappuzha vide Government Order read as 1st paper above. As per the Interim Order read as 2nd paper above, the Hon'ble Kerala Administrative Tribunal stayed her transfer to W&C, Alappuzha and she continued in Victoria Hospital, Kollam even though there was no sanctioned post of Consultant, Gynaecology to accommodate her.

2. The Hon'ble Tribunal passed final judgement in OA No.520/2019, as per 3rd paper above wherein the OA was dismissed for being infructuous, as the applicant had completed more than five years in the same hospital itself.

3. In the above circumstances, orders are issued to immediately relieve Dr. Pushpakumari. C.V, Consultant Obstetrics and Gynaecology, from Victoria Hospital, Kollam. She will report for duty at W&C Hospital, Alappuzha, as instructed in the Government Order read as first paper above.
