ORDER

As per Government Order read as 1st paper above, the Government approved the select list prepared by the Departmental Promotion Committee (Higher) that was held on 30/03/2021 for the promotion to the cadre of Administrative Assistant in Health Services Department for the year 2021.

- 2. Director of Health Services, Thiruvananthapuram vide his letter read as 3 rd paper above, has reported that there are 8 vacancies of Administrative Assistants in the Department and submitted a proposal for promotion and posting to the cadre of Administrative Assistant from the cadre of Lay Secretary & Treasurer/ Senior Superintendents/ in Health Services Department.
- 3. The government examined the matter in detail and found that two officers viz, Shri. Shajikumar G and Smt. K P Binilbala ranked Sl No. (1) and (3) in the Seniority List respectively had been superseded, since disciplinary action for a major penalty was

pending against them as per Note (i) below Rule 28 (b) (i) (7) of Part II of KS&SSRs. However, they could have been included in the current Select List ranked at (1) and (3) respectively. As per the above note below Rule 28 (b) (i) (7) of Part II of KS&SSRs, the vacancies filled by them should have been filled only on a temporary basis by the next person from the approved list, and they should have been regularized accordingly only against the first regular vacancies arising along the way the in future.

4. Moreover, Shri. K V Sudharsanan, who actually was 2 nd in the seniority list happened to be ranked (1) in the Select List. But the inclusion in the Select List was provisional, since departmental proceedings for the imposition of a minor penalty was pending against him. As the vacancies consequent to the supersession of Shri. Shajikumar G, and Smt. K P Binibala and that of Shri. K V Sudharsanan who was provisionally included in the Select List had to be filled up temporarily, as per G.O read as 2 nd paper above, the following Senior Superintendent & Lay Secretaries who were included in the Select List was promoted as Administrative Assistants on a temporary basis;

- 5. Meanwhile, Shri. Shajikumar G (Date of Birth 19/05/1965), Shri. K V Sudharsanan (Date of Birth 31/05/1965) and Smt. Mary Sudha (Date of Birth 01/06/1965) retired from service on 31/05/2021. As per the report of the Director of Health Services, all the vacancies of Administrative Assistants occurred with effect from 1/6/2021. Since Smt. Mary Sudha (Date of Birth 01/06/1965) has been retired from service on 31/05/2021, her case is excluded from regularisation. The temporary promotion granted to Sri.Gireeshkumar P and Sri. Biji C Mathew is to be regularised with effect from 1/06/2021.
- 6. In the circumstances, Government are pleased to regularise the temporary promotion granted to Sri.Gireeshkumar P and Sri. Biji C Mathew under Note (i) below Rule 28 (b) (i) (7)of Part II of KS&SSR as Administrative Assistant with effect from
