ORDER

Dr.Aysha.K.M was promoted to the post of Consultant vide Government Order read as 1st paper above and posted at W&C Hospital, Ponnani. But due to the non availability of vacancy at Ponnani, she was re-posted at District Hospital, Thodupuzha. But this posting was also not implemented due to the non-availability of vacancy. The applicant, as there exists an open vacancy at General Hospital, Changanassery, by her representation dated 04.12.2019 requested for her posting at that station. But before her representation received in Government, the Director of Health Services submits a proposal for the posting of Dr.Vijaya, Consultant at General Hospital, Changanassery. Since an open vacancy in the post of Consultant in Gynaecology was available at North Paravur, the applicant as per her representation dated 10.02.2020 requested for posting at North Paravur. But it was also rejected by Government and has directed the applicant to join duty at Sulthan Bathery. In the meanwhile, Dr. Vidya Bahuleyan, Junior Consultant (O&G) was posted at General Hospital, Muvattupuzha by the Director of Health Services vide her order dated 15.05.2020.

- 2) As per interim order in OA 569/2020 dated 18.05.2020, the Hon'ble Kerala Administrative Tribunal gave a direction not to relieve Dr.Aysha.K.M from the present station ie., General Hospital, Moovattupuzha and directed the Government Pleader to get instruction whether a vacancy of Consultant (O&G) is available at Taluk Head Quarters Hospital, Nedumkandom in Idukki. This stay order was extended for further periods by subsequent interim orders of the Hon'ble Tribunal and finally for two months by the order dated 05.11.2021.
- 3) The Director of Health Services as per the letter read as 3rd paper above has reported that vacancy in the post of Consultant in Gynaecology is present at Taluk Hospital, Ranni, Pathanamthitta; General Hospital, Kanjirappalli, Kottayam; Taluk Head Quarters Hospital, North Paravoor, Ernakulam; Taluk Head Quarters Hospital, Sulthan Bathery, Wayanad and Taluk Head Quarters Hospital, Vaithiri, Wayanad.
- 4) Government have examined the matter and are pleased to issue orders posting Dr.Aysha.K.M in the vacancy of Consultant in Gynaecology, at General Hospital, Kanjirappalli, Kottayam.
