Sub:- HSD – Speciality cadre – Excluding names of Dr.Chithra.K.R and Dr.Joicy Kurian from the seniority list of medical officers in speciality cadre published during implementation of speciality cadre - Appeals called for – req

Government vide order referred 1<sup>st</sup> cited have published the seniority list of medical officers under Physical Medicine and Rehabilitation (PMR) speciality at the time of implementation of speciality cadre during the year 2010. Dr.Chithra.K.R is included in the list as Rank No.28 and Dr.Joicy Kurian is included in the list as Rank No.30. The date of entry in service of Dr.Chithra.K.R mentioned in seniority list is 27-07-2005 and that of Dr.Joicy Kurian is 29-07-2005.

Dr.Abdul Gafoor.M. Junior Consultant (PMR) has filed an appeal stating that the date of entry of Dr.Chithra.K.R & Dr.Joicy Kurian mentioned in the seniority list is wrong and requested to review the seniority list. Accordingly, the service details of Dr.Chithra.K.R & Dr.Joicy Kurian have been sought from the Accountant General (A&E), Kerala. As per service details furnished by Accountant General (A&E). Kerala. the date of entry in service of Dr.Chithra.K.R is 27-06-2008 and that of Dr.Joicy Kurian is 27-12-2008. Dr.Chithra.K.R & Dr.Joicy Kurian have entered in service after 31.12.2006 and hence they are not eligible for inclusion in the seniority list published at the time of implementation of speciality cadre as per clause 5 E (iii) of Appendix in Kerala (Health Services) Medical officers Special Rules, 2010.

Hence it is decided to exclude Dr.Chithra.K.R & Dr.Joicy Kurian from the seniority list of medical officers under Physical Medicine and Rehabilitation (PMR) speciality published vide order referred 1<sup>st</sup> above.

Appeals in this regard may be submitted to this office through proper channel within 15 days from the date of publishing this notice.
