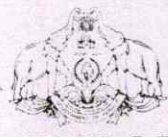

**CIRCULAR**

Sub: H&FWD – Interim Commission for Allied and Health Care Professions – Nomination of Members in the Interim commission – Application called for – reg.

- Ref: 1. National Commission for Allied and Health Care Professions Act 2021 published in the Gazate of India extraordinary No. 16 dated 28/03/2021 .
- 2. Notification No. G.S.R 346 (E) published in the Gazette of India extraordinary No. 1875 dated 25/05/2021.
- 3. Notification No. S.O 3944 (E) dated 21/09/2021 published in the Gazette of India extraordinary No. 3610 dated 23/09/2021.

The Government of India as per the Notification read 3rd above, have constituted an Interim Commission for Allied and Healthcare Professions for a period of three years or until a regular commission is constituted under section 3 of the National Commission for Allied and Health Care Professions Act 2021 whichever is earlier. As per the notification read 2nd above, Government have published National Commission for Allied and Healthcare Profession Rules, 2021. The qualifications, experience and manner of appointment of members of the interim commission are prescribed in Rule 16 of the said Rules. Accordingly, a person possessing a postgraduate degree in any profession of a recognized category of allied and healthcare sciences from any University, with experience of not less than fifteen years in the field of allied and healthcare sciences, out of which at least seven years shall be as a leader in the allied and healthcare professions and having an outstanding ability, proven administrative capacity and integrity, can be nominated as a member in the interim commission. Kerala will also be sending its nominations towards the members of the interim commission.

Applications are invited from eligible persons who are willing to be nominated by Kerala as a member of the interim commission representing any of the recognized categories as incorporated in the schedule of the National Commission for Allied and Healthcare Professions Act 2021.

Application with copies of testimonials satisfying the above criteria shall reach to Government on or before 3.00 PM on 19/03/2022. The applications shall be sent to the following mail ID : healthkdepartment@gmail.com.
