The following candidates have been advised by the Kerala Public Service Commission as per the letter read above for appointment to the post of Junior Consultant (Anaesthesia) is temporarily appointed in the Health Services Department as Junior Consultant (Anaesthesia) in the scale of pay of Rs. 63700-123700/-, under clause(1)sub rule(a) of Rule 9 of the General Rules as provided for in Rule 10 (b)of those Rules(vide G.O.(P)No.49/74/PD dated 05.03.1974) are posted to the stations noted against their name subject to the condition that your appointment shall be terminated without further notice if the appointing authority is not satisfied with your conduct and antecedents on subsequent verification. You shall be eligible for appointment in regular service in accordance with rules only if your character and antecedents are found satisfactory on subsequent verification. The appointment is also subject to Rule 3(C) of General Rules of Kerala State and subordinate Service Rules 1958.

You are directed to report for duty before the District Medical Officer of Health concerned, on or before **25.08.2022** with relevant records in original to prove your qualification, Date of birth, Certificate of Registration with Travancore-Cochin Medical Council and Medical Certificate of Physical Fitness of Good Health obtained from a Medical Officer not below the rank of Civil Surgeon in Government Service (as per G.O (P) No.20/2011/P&ARD, Thiruvananthapuram dated 30/06/2011). The District Medical Officer of Health should verify the documents and also ensure the identity of the candidate before he is actually permitted to join duty in the respective institution to which the candidate is posted.

The extension of joining time should not be granted to any candidate appointed to the post of Junior Consultant.

The District Medical Officers of Health will obtain the enclosed attestation form duly filled up and signed by the candidate before he is allowed to join duty and forwarded to this office.

The District Medical Officer of Health will also satisfy themselves about the identity of the candidate with reference to the photograph and signatures affixed thereon in the identification certificate, which is enclosed and the fact of having done so should be recorded on the identification certificate itself and the same forwarded to this office.

If the candidate is already employed in any other department, he may be permitted to join duty only after obtaining relieving order issued by the competent authority.

Those Medical officers who are now working on contract / provisional basis should be terminated according to seniority when the Public Service Commission candidates join duty.

The application for correction of date of birth, if any required should be made by the candidates within five years from the date of entry in service.

All new PSC hands should complete induction training within three months and will produce the certificates from the Training coordinator.

RTC (Report of Transfer of Charge) should be forwarded promptly.
