## ORDER NO. EA2-9157/2024/DHS- (2) Dated:26-07-2024

Dr.Haneef Husain T, Dr.Yahya Abdul Basith M, Dr.Sabin B, Dr.Muhammed Yasir K, Dr.Mohamed Faisal P V, Dr.Aboobacker

Sidhiue Chittangad & Dr.Shafeed P Assistant Surgeons of General Hospital, Manjeri were posted at Taluk Hospital Areekode and Taluk Head Quarters Hospital Kondotty on working arrangement basis as per order read 5th above. Later they were transferred to respective hospitals as their posts were shifted from Manjeri General Hospital as per orders read 3rd& 4th above. Aggrieved by these orders they were field OA (EKM) No.204,205,207,209,2015,2016 & 996 of 2024 before the Honourable Kerala Administrative Tribunal. In those Original Applications, the main grievance of the applicants was that at present are they lost their opportunity to submit application for general transfer.

- 2. The Hon'ble Kerala Administrative Tribunal in the common order read as 1st paper above, disposed the O.As by allowing the applicants to submit their representation before the second respondent. The Hon'ble Tribunal made it clear that they are free to submit their option as in the case of those who could submit option on the basis of the Circular inviting application for General transfer. The Hon'ble Tribunal then directed the 2nd Respondent (Director of Health Services) to consider their representation along with other claimants for the General transfer irrespective of the fact that they were not included in the draft transfer list. As per Order red as 2nd above, the Hon'ble Tribunal has directed to consider the request of Dr.Mohamed Faisal P V.
- 3. In the light of Orders of the Hon'ble Kerala Administrative Tribunal Dr.Haneef Husain T,Dr.Yahya Abdul Basith M and Dr.Muhammed Yasir K, Dr.Sabin B, Dr.Mohamed Faisal P V and Aboobacker Sidhiue Chittangad have submitted their representations as per read 6th & 7th paper above.
- 4. The above representation have been examined in detail along with the merit of other claimants in General Transfer 2024 of Assistant

Surgeons.

(a). It is seen that Dr.Haneef Husain T, Assistant Surgeon, Taluk Hospital, Areekode submitted the following options in general transfer;

- 1.Primary Health Centre, Pandikkad
- 2. Primary Health Centre, Porur
- 3. Taluk Hospital, Areekode

On examination of these options with the other claimants in General transfer 2024, it is found that Dr.Sini Kareem M from PHC Kurukkanmoola, Wayanad is the eligible incumbent to be posted at Primary Health Centre Pandikkad. Dr.Jayakrishnan C, Assistant Surgeon, Taluk Hospital Kuttipuram who is having SC/ST and Intercaste Marriage Protection is eligible to be posted at Primary Health Centre Porur. The 3rd option of Dr.Haneef Husain T is Taluk Hospital ,Areekode, wherein he is already working. Therefore it is decided and hereby order that there is no need to transfer him from the present institution.

- (b). The options of Dr.Muhammed Yasir K, Assistant Surgeon, Taluk Hospital, Areekode is as follows:
  - 1. Community Health Centre Omanoor
  - 2. Community Haelth Centre Vengara
  - 3. Taluk Hospital Areekode

On examination of these options, it is seen that there are 2 vacancies at Community Health Centre Omanoor. Dr.Manulal N, Community Health Centre, Cheruvadi, Kozhikkode who is having the protection of less than 2 years to retire and Shamini P H, CHC Narikuni, Kozhikkode who is coming from outstation to home station are the eligible incumbents to be posted at CHC Omanoor. Considering his 2<sup>nd</sup> option, Dr.Muhammed Yasir K is eligible to be posted at CHC

Vengara. In this circumstances Dr. Muhammed Yasir K Assistant Surgeon, Taluk Hospital Areekode Malappuram is hereby transferred and posted to Community Health Centre Vengara Malappuram Vice Dr. Sameena M.

- (c). The Options of Dr. Yahya Abdul Basith M, Assistant Surgeon, Taluk hospital Areekode are as follows:
  - 1. Taluk Hospital Wandoor, Malappuram
  - 2. Taluk Hospital Areekode, Malappuram

On verification it is seen that Dr.Yahya Abdul Basith M is eligible to be posted at his 1<sup>st</sup> option. In the circumstances, Dr.Yahya Abdul Basith M, Assistant Surgeon, Taluk Hospital Areekode, Malappuram is hereby transferred and posted to Taluk Hospital Wandoor, Malappuram vice Dr. Riyas Kanniyan.

- (d). The Options of Dr.Mohamed Faisal P V,Assistant Surgeon, Taluk hospital Areekode are as follows:
  - 1. Primary Health Centre Angadippuram
  - 2.Primary Health Centre Chemmalassery
  - 3. Primary Health Centre Thazhekode
  - 4. Primary Health Centre Vettathur
  - 5. Primary Health Centre Makkaraparamba
  - 6.Primary Health Centre Aliparamba
  - 7. Primary Health Centre Pang
  - 8. Primary Health Centre Anakayam
  - 9. Primary Health Centre Elamkulam

On examination of these options, it is seen that as per the norms of General Transfer no vacancy exists at Primary Health Centre Angadippuram. Considering his 2nd option Dr. Mohamed Faisal P V is eligible to be posted at Primary Health Centre Chemmalassery. In the

circumstances Dr.Mohamed Faisal P V Assistant Surgeon Taluk Hospital Areekode is hereby transferred and posted to Primary Health Centre Chemmalassery vice Asha Jalal.

- (f). In their representations, Dr.Sabin B and Dr.Aboobacker Sidhiue Chittangad have requested to retain them in the their present Institution itself. These requests are examined in detail and they are hereby allowed to continue in Taluk Head Quarters Hospital Kondotty, Malppuram as per transfer norms.
- (g). Dr.Shafeed P, Assistant Surgeon, Taluk Head Quarters Hospital Kondotty, Malppuram has already submitted online application for General Transfer 2024 of Assistant Surgeons. In his application, one of his options is Taluk Head Quarters Hospital Kondotty. As per Orders read as 3rd and 4th above, he is presently working at Taluk Head Quarters Hospital Kondotty itself. Therefore he is here by retained at Taluk Head Quarters Hospital, Kondotty as per transfer norms.
- 5. The directions contained in the orders read as 1st & 2nd paper above of the Hon'ble Kerala Administrative Tribunal is complied with accordingly.
