The Final list of Assistant Surgeons for General Transfer 2024 was published vide the order read 1st above. In that order it was permitted to the Medical Officers (those who were included in the draft transfer list, but not included in final transfer list, and those who were not included in the draft transfer list, but included in the final transfer list) to file their genuine complaint/grievance, if any, within 3 days. Even though some representations received from Medical Officers, no valid

- 2. Some Assistant Surgeons of General Hospital, Manjeri were posted at Taluk Hospital Areekode and Taluk Head Quarters Hospital Kondotty on working arrangement basis as per order read 4 th paper above. Later they were transferred to respective hospitals as their posts were shifted from Manjeri General Hospital as per orders read as 5th &6th above. Aggrieved by these orders they were field OA (EKM) No.204,205,207,209,2015,2016 & 996 of 2024 before the Honourable Kerala Administrative Tribunal. The Hon'ble Tribunal issued direction to the Director of Health Services as per Orders read as 2nd and 3rd above. In compliance of these orders some applicants were included in the general transfer final list 2024 of Assistant Surgeons. Therefore some modification is necessary in the Annexure of the General Transfer issued in Order 1st above and those modifications are hereby ordered as appended to this order.
- 3. The controlling officers are hereby directed to relive and permit to join the Medical officers who are included in the General Transfer 2024 of Assistant Surgeons with immediate effect without awaiting the arrival of substitute/s. The District Medical Officer of Health concerned should ensure that the Medical Officers who are transferred are joined in the respective station within 15 days from this order. No salary shall be drawn and disbursed to those who continue in the station in violation of the transfer order. The details of non joining officers should be reported to the Director of Health Services after the above period.
- 4. The posting of Medical Officers at various hospitals against Casualty Medical Officer Posts shall be reviewed later from this office

on the basis of proposals submitting by the superintendents of concerned institutions. Proposal should be prepared on the basis of services seniority and service period in Casualty Medical Officer posts. The Supdts should submit such proposal through District Medical Officers concerned.

Joining RTC should be furnished promptly.
