Domi. J, Varavilathope House, Poovar, Thiruvananthapuram - 695525, (Communication Address- Y1, Sarovaram Apartments, Kumaranalloor, Kottayam Kumaranalloor) who has been advised by the Kerala Public Service Commission as per their letter read as above for appointment to the post of State Mass Education and Media Officer is temporarily appointed in the Health Services Department in the scale of pay of Rs. 95600-153200, under Rule 9(a)(i) of Kerala State and Subordinate Service Rules 1958, is posted to the **Directorate of Health Services, Thiruvananthapuram** subject to the condition that his appointment shall be terminated without further notice if the appointing authority is not satisfied with your conduct and antecedents on subsequent verification. He shall be eligible for appointment in regular service in accordance with rules only if his character and antecedents are found satisfactory on subsequent verification. The appointment is also subject to Rule 3(c) of General Rules of Kerala State and subordinate Service Rules 1958.

2. The candidate is directed to report for duty beforethe **Director of Health Services** within **15** days on publishing the posting order on the website of DHS Kerala failing

which action will be taken to cancel the appointment.

- 3. The candidate should produce the following documents at the time of joining duty.
 - 1. Original documents to prove the date of birth and educational qualification.
 - 2. Original advice memo received from KPSC.
 - 3. Certificate of physical fitness obtained from the Medical Officer in Government Service not below the rank of Civil Surgeon/Consultant. (as prescribed in GO(P). No.20/2011/P&ARD,dtd 30.06.2011)
- 4. If there is any discrepancy found, the candidate should not be allowed to join duty. After the candidate is allowed to join duty, the copy of identification certificates may be kept in the concerned file under safe custody.
- 5. Candidates already employed in any other department in State Government service will be permitted to join duty only after obtaining relieving order issued by the competent authority. In case of requirement of extension of joining time beyond 45 days in such cases on administrative reasons, extension up to a maximum of 60 days from the date of appointment order will be admissible. Application for such extension of joining time beyond 45 days shall be submitted with recommendation from the present appointing authority.
- 6. In case of candidates employed in Central Government service/Other State service/State & Central Public sector organizations/Banks, extension of joining time up to 90 days will be admissible on request and also if application is submitted on proper grounds. Extension of joining time up to a maximum of 45 days will be admissible in normal course if required, for applications submitted with proper reasons and also on the condition that the appointing authority is satisfied with the reason specified for extension of joining time.
- 7. The entitlement register shall be submitted to the Accountant General,

Thiruvananthapuram by the candidate within one week from the date of joining duty.

The RTC (3 copies), Appendix I and Personal Memorandum received from the

candidate should be sent to this office for PSC/ Police Verification. The appointment

shall be regularized only after the receipt of verification certificate from KPSC and

Police authorities.

8. The application for correction of date of birth, if any required should be made by

the candidates within five years from the date of entry in service.

9. In the case of those candidates who fail to join duty within stipulated time, their

appointment will be cancelled, and the vacancy will be reported to Kerala Public

Service Commission as 'Not Joining Duty.' RTC (Report of Transfer of Charge)

should be forwarded promptly.

10. The appointment is subject to Part II Rule 7 of General Rules of Kerala Stateand

subordinate Service Rules 1958.

11. No separate appointment orders will be sent to the candidates. Hence, they are

directed to download the appointment order from the website www.dhskerala.gov.in
