ORDER

Dr Sareesh Chandran, Assistant Surgeon filed OA 1238/2024 before the Hon'ble Kerala Administrastive Tribunal aggrieved by the Annexure A6 order by which he was transferred to District Hospital, Idukki.

- 2. The Hon'ble Kerala Administrative Tribunal as per order read as 2nd paper above, has directed the 1st respondent to consider and pass orders on Annexure A7 appeal within a period of two months from the date of receipt of a copy of the order.
- 3. In the Annexure A7 appeal read as 1 st paper above, the applicant submitted the following.

The applicant joined service as Assistant Surgeon on 2013 and served at Idukki District for more than 4 years. In 2017 he was transferred to CHC, Kanjikuzhy, Idukki. In General Transfer 2023, he was transferred to PHC, Kodikulam, Idukki. Dr. Sam V John who was in service at Kodikulam PHC filed OA before the Hon'ble Kerala Administrative Tribunal . As a result Government issued order retaining Dr. Sam V John and the applicant at their respective stations. In General Transfer 2024, the applicant was proposed to transfer to Idukki District Hospital. He filed appeal before the Director of Health Services against this. But he was included in the final transfer order. The applicant again made a representation before the Director of Health Services to exclude his name from the transfer to Idukki district hospital. The applicant faced several medical difficulties relating to asthma during his 4 years service at Idukki. The current transfer would again put him to the same medical conditions. At present only two Assistant Surgeons are working at Kanjikuzhy CHC out of three vacancies present. Two of them including the applicant are proposed to be transferred to different stations and there has not been any appointments proposed to Kanjikuzhy CHC. Thus there would be no Assistant Surgeon stationed at Kanjikuzhy CHC if the applicant is transferred. Applicant requested to transfer him to PHC, Kodikulam or FHC, Mariyapuram or CHC, Vathikuddi or to retain him at Kanjikuzhy CHC.

3. The Director of Health Services as per letter read as 3 rd paper above reported the following.

The applicant has joined Health Services Department on 01.03.2014.

He has been working at Community Health Centre, Kanjikuzhy, Idukki District since 26.12.2016. He had applied for General Transfer 2024 with option as Primary Health Centre, Kodikulam. As per the General transfer norms, Dr. Jayamol V J , PHC, Manjalloor, Ernakulam having station seniority from 01-12-2021 with SC/ST protection posted at Primary Health Centre, Kodikulam, which was the option of the applicant. The applicant requested General Transfer on the basis of SC/ST protection. He is working at Community Health Centre, Kanjikuzhy, Idukki since 26.12.2016 and it is seen that the applicant has already availed his protection at present station from 26.12.2016 to 30.04.2024. Hence eligible incumbent having SC/ST protection is posted at PHC, Kodikulam. Dr. Sareesh Chandran has been working at his present station for more than 7 years.

4. Government have examined the matter in detail. Dr. Sareesh Chandran is working at Community Health Centre, Kanjikuzhy, Idukki since 26.12.2016 and it is seen that the applicant has already availed his protection at present station from 26.12.2016 to 30.04.2024. He has been working at his present station for more than 7 years. In the above circumstances Annexure A7 appeal submitted by the applicant is hereby rejected

5. The order of Hon'ble Kerala Administrative Tribunal read as 2^{nd} paper above is complied with as above.
