ORDER

As per General Transfer order read as 1st paper above, Dr.Sudeep.T.K., Consultant in Anaesthesia, W&C Hospital, Alappuzha was transferred to General Hospital, Kottayam and Dr.Sunjith Ravi, Consultant in Anaesthesia, Taluk Head Quarters Hopsital, Chirayinkeezh was posted at W&C Hospital, Alappuzha. Dr.Sudeep filed OA 867/2022 before the Hon'ble Tribunal seeking stay for his transfer from W&C Hospital, Alappuzha. The Hon'ble Tribunal as per the interim order read as 2nd paper above stayed his transfer to General, Hospital, Kottayam stating that the 1st respondent ie. State of Kerala represented by the Secretary to Govt., will ensure that the applicant and the 4th respondent, Dr.Sunjith Ravi are retained at their respective stations. But before receiving the stay order, Dr.Sunjith Ravi joined W&C, Alappuzha

and he was unable to join back Taluk Head Quarters Hospital, Chirayinkeezh since his substitute had joined in that station. By virtue of the stay order Dr.Sudeep also continued at W&C Hospital, Alappuzha. To get out of this crisis, as per Government Order read as 3rd paper above Dr.Sunjith Ravi was given posting at General Hospital, Kottayam and he joined duty in the station on 07.10.2022.

2) The Director of Health Services as per letter read as 4th paper above has requested to regularise the period Dr.Sunjith Ravi continued at W&C Hospital, Alappuzha from 19.05.2022 to 29.09.2022 as eligible leave and sought for instructions regarding sanctioning of leave salary to him.

3) Government have examined the matter in detail and are pleased to accord sanction to regularise the period of continuance of Dr. Sunjith Ravi, Consultant (Anaesthesia) at W&C Hospital, Alappuzha from 19.5.2022 to 29.09.2022 without a post as eligible leave and also to sanction leave salary to the Medical Officer. The Director of Health Services shall take necessary steps for disbursing the leave salary to the Medical Officer.


