## <u>Abstract</u>

Health & Family Welfare Department – Establishment – Implementation of Specialty Cadre in Health Services Department– Modified placement/postings in various cadres based on appeals- Orders issued.

## ORDER

As per G.O read as Ist paper above, Government have issued orders for temporary promotion and placement/posting in various cadres on implementation of Specialty Cadre/Administrative Cadre/ General Cadre / Dental General Cadre / Public Health Lab cadre / Clinical Lab and Blood Bank Cadre in Health Services Department. Meanwhile, a number of doctors have filed appeals before the Government against their posting/placement as per the order read as Ist paper above on various grounds. A number of Writ Petitions have also been filed before the Hon'ble High Court so far, with request to stay the operations of the G.O read as Ist paper above and for posting according to their options.

- 2. All the complaints/appeals received as on 18.6.2010 in Government and Directorate of Health Services have been examined in detail and postings and placements made accordingly are appended to this order as Annexure. Hence all the appeals for postings/placement are finalised forthwith.
- 3. In the circumstances, Government are pleased to order that the placement/postings of Medical Officers ordered as per Government orders read as Ist and 2nd papers above stand modified to the extent shown in Annexure to this order. The postings/Placements ordered are subjects to final decisions in various Writ Petition filed before the Honourable High Court for the placement/postings in Specialty Cadre of doctors in Health Services Department.
- 4. Director of Health Services will publish this order along with Annexure in the website (in pdf format) and the incumbents are authorized to use the printouts of their respective promotion and posting orders for official purpose. Those who are posted in Specialty Cadre as per the orders read as Ist and 2nd cited read above, but have not so far reported for duty will join in the new station after getting relieved from the present station directly.

- 5. The District Medical Officers (Health) / Heads of the institutions will verify the identity of the Medical Officers and permit them to join duty and to furnish copy of the CTC / RTC to the Director of Health Services forthwith.
- 6. All the Medical Officers posted under Specialty Cadre as per the Government orders read above will report for duty on or before 6.7.2010 failing which disciplinary action will be initiated against them.
- 7. Government orders read as 1st and 2nd papers above stand modified to this extent.
