The candidates are directed to report for the duty before the **Director of Health Services** within 07 days on publishing the posting orders in the website of DHS Kerala failing which action will be taken to cancel appointment.

The candidates should produce the following documents at the time of joining duty.

1. Original documents to prove the date of birth and educational qualification.
2. Original advice memo received from KPSC
3. Certificate of physical fitness obtained from the Medical Officer in Government Service not below the rank of Civil Surgeon/ Consultant.
4. Original NCLC (Non Creamy Layer Certificate) of the candidate with Sl No 1 & 3 should be submitted at the time of joining duty.

If there is any discrepancy found, the candidates should not be allowed to join duty. After the candidate is allowed to join duty, the copy of identification certificates may be kept in the concerned file under safe custody.

The appointment of the candidate is subject to Rule 3 (c) of the General Rules of the Kerala State Subordinate Service Rule 1958 and the service is liable to be terminated without prior notice. The appointment is purely provisional and the candidates are eligible for appointment in regular service only if the character and antecedents are found satisfactory on verification. The appointment shall be terminated without further notice, if the appointment authority is not satisfied with their conduct and antecedents on subsequent verification.

The entitlement register shall be submitted to the Accountant General, Thiruvananthapuram by the candidate within one week from the date of joining duty. The RTC (3 copies), Appendix 1 and Personal Memorandum received from the candidate should be sent to this office for PSC/ Police Verification. The appointment shall be regularised only after the receipt of verification certificate from KPSC and Police authorities.

The application for correction of date of birth, if any required should be made by the candidates within five years from the date of entry in service.

No separate appointment orders will be sent to the candidates. Hence they are directed to download the appointment order from the website www.dhskerala.gov.in

The posting will be renewed during general transfer 2024 if necessary.
