ORDER

The Director of Health Services, as per letter read as 3rd paper above has requested Government to revise the existing qualification and method of appointment for the post of Publication Assistant in Health Services Department fixed as per Government Order read as 2nd paper above.

Government, after having examined the proposal in detail, in consultation with Kerala Public Service Commission, are pleased revise the Government Order read as 2nd paper above regarding qualification and method of appointment for the post of Publication Assistant in Health Services Department as follows:

I. Qualification

i) Degree in Journalism

OR

Degree in any subject with Diploma in Journalism

Desirable

ii) Must have produced or published any articles or books in Malayalam

II. Method of appointment

- i)By transfer from the following categories in the Health Services Department.
 - 1. Junior Health Inspector Grade I (in their absence Grade II)
 - 2. Lab Technician Grade I (in their absence Grade II)

3. Junior Public Health Nurse Grade I (in their absence Grade II)

OR

(in the absence of candidates under item (i) above)

(ii) By direct recruitment.

III. Age Limit

No person shall be eligible for appointment by direct recruitment to the post if he/she has not completed 18 years of age or has completed 36 years of age as on the 181 day of January of the year in which applications for appointment are invited, with usual relaxation admissible to candidates belonging to Scheduled Caste, Scheduled Tribes and Other Backward Classes.

IV. Probation

The period of probation shall be one year within a continuous period of two years for "by transfer "appointment" and two years within a continuous period of three years for "Direct Recruitment".

The Government order read as 2nd paper above stands modified to this extend.
