ORDER NO. EA 2 -7/2024/DHS DATED :20-03-2025

In Health Services Department the entry cadre post of a Medical Officer is Assistant Surgeon/Casualty Medical Officer/Resident Medical Officer. After getting appointment in General Cadre i.e Assistant Surgeon/Casualty Medical Officer/ Resident Medical Officer, a medical officer has to exercise his /her option for placement in Administrative Cadre, Speciality Cadre or Public Health Lab cadre during the period of probation itself as per Para 5 of the Kerala Health Services (Medical Officers) Special rules, 2010 issued under the Government Order read as 1st paper above. In the Rule 7 of the above special rules, it is insisted that those who are not exercised their option, will be retained in the General Cadre. In the Rule 6 it is specifically made it clear that Option once exercised shall be final. Dr. Chitra.S and Dr. Chithra Revi entered service as Assistant Surgeons. Both of them were having Post Graduate Degree in ENT Specialty, at the time of their appointment itself and both of them had opted for placement in Specialty cadre in ENT Specialty, during the period of their probation. They were included in the seniority list read as 2nd above for the Junior Consultant under ENT specialty. Later as per Circular read as 3rd above, the Director of Health Services called for the details of Medical Officers who are opted ENT Specialty cadre. In the Annexure of that Dr. Chitra.S and Dr. Chithra Revi were included for Circular placement. The application of Dr. Chitra.S for relinquishment of placement has been rejected by the Director of Health Services and the Government. For allowing relinquishment, both Dr. Chitra.S and Dr. Chithra Revi filed OA No.s 300 & 392 of 2024. Based on the interim directions in the 4 & 5th papers above, Dr.Chitra S, Assistant Surgeon, Primary Health Centre, Uzhamalakkal, Thiruvananthapuram and Dr.Chithra Revi, Assistant Surgeon, Primary Health Centre, Ottoor, excluded from placement under ENT Thiruvananthapuram were Specialty Cadre as per Proceedings read as 6th paper above. The Hon'ble Tribunal in the final Order read as 7th paper above, set aside the communications rejecting the relinquishments and further directed to act upon the relinquishment letters submitted by the applicants.

Against this Order, the Government of Kerala filed OP (KAT) Nos 420/2024 & 422/2024 before the High Court of Kerala. The Division Bench of Hon'ble High Court of Kerala in the Judgment read as 8th paper above allowed the OP (KAT) Nos 420/2024 & 422/2024 and set aside the Order read as 7th paper above.

2. In the above circumstances, placement has to be given to Dr.Chitra S and Dr.Chithra Revi.

3. The Placement to Specialty Cadre are done in the existing open vacancies. The following are the present vacancies in the cadre of Junior Consultant ENT under specialty cadre.
